### RELEASE AND WAIVER OF LIABILITY, ASSUMPTION OF RISK, AND INDEMNITY AGREEMENT

## STUDENT ACCOUNT POLICIES

### Please read before enrolling student.

1. Tuition is due the first week of the month in which classes are held. If you pay before the first of the month, you may deduct \$5 from each student's tuition. After the first of the month, you owe the regular tuition. A \$10 late fee will be charged for accounts that are more than 30 days past due and your children may lose their spots in classes.
2. If you attend one or more classes in a given month, you are liable for that month's tuition. We do not prorate tuition except for the initial month.
3. We require a minimum of two weeks notice for class withdrawal. You will be charged for the two weeks, and your children are encouraged to attend classes.
4. An annual enrollment fee of \$20 per student (max \$40 per family) is due on each anniversary date of enrollment.
5. A \$15 charge will be made for each returned check.
6. If an account is submitted for collection, a \$25 processing fee will be added.
7. Our tuition is based on a year's tuition rate divided by 12 to arrive at our monthly tuition. Holidays and breaks are factored into the setting of tuition, therefore we do not prorate for these closings. We do offer makeups for bad weather and other unplanned closings.
8. Makeups must be arranged in advance by contacting the main office staff. Makeups are not guaranteed and are available only if there are class openings. To qualify for makeups, students must be actively enrolled in classes. One makeup per month is permitted. Call 972-377-3137 to arrange makeups.
9. Private lessons are available for currently enrolled students. Please contact the Program Director to arrange private lessons. Payments must be made to FGC, not to the instructors.
10. Be sure to contact the office staff, not the instructors, in writing, in person or by phone about any changes to classes, accounts, addresses, phone numbers, or withdrawals.
