I hereby release, discharge and covenant not to sue Frisco Gymnastics Center, its respective administrators, directors, agents, officers, volunteers and employees, other participants, any sponsors, advertisers, and, if applicable owners and lessors of premises on which the Activity takes place, (each considered one of the "RELEASEES" herein) from all liability, claims, demands, losses, or damages, on my account caused or alleged to be caused in whole or in part by the negligence of the "releasees" or otherwise, including negligent rescue operations and future agree that if , despite this release, waiver of liability, and assumption of risk, I or anyone on my behalf, makes a claim against any of the Releasees, I will indemnify, save, and hold harmless each of the Releasees from any loss, liability, damage, or cost, which any may incur as the result of such claim.

WELCOME CAMPERS AND PARENTS:

Thank you for choosing to spend your summer with us. We are very excited about our summer camp program and look forward to having you with us. This letter is to welcome you and remind you of what week(s) you registered for and what to bring.

DROP OFF AND PICK-UP POLICY

If you need to drop off special instructions, medications, forms, etc., please make sure you arrive a few minutes early on the first day to get this done. No camper will be allowed in unless all forms and payment have been made and turned in. Please be prompt when picking up your camper at the end of the day. If your child remains at camp past their pick-up time, there will be an additional charge. Half Day campers will be charged for full day and full day campers will be charged an additional \$35.

PAYMENT POLICIES

All balances are due by the first day of camp. If you register after June 1st, you are required to pay in full at the time you register. We have a strict NO REFUND policy and you may not transfer monies to fall sessions. You may change weeks of camp, however, there is a \$25 change/transfer fee. Remember: a camp week is only guaranteed when registration and payment is made. You are paying for your child's spot in camp, not his/her attendance.

CAMP FORMS

All forms must be returned to us completed or your camper will not be allowed to participate. Medical information MUST be filled out completely and ALL contact numbers must be current.

CAMPERS CHECK LIST

- _____ Comfortable shorts and camp T-shirt are to be worn at all times. Camp T-shirt will be provided and MUST be worn during field trips. Younger children should bring extra clothing.
- _____ Please bring a sack lunch.
- _____ Do not send any valuables, we will not be responsible for them! The office does not carry change, if bringing change for snack machines, BRING EXACT CHANGE!
- _____ Medication sent with instructions and in ORIGINAL container and must be dropped off at check-in.

CAMP REGISTRATION AND TUITION

Payment Policies: All balances must be paid in FULL before camp starts. If you register after May 29, 2007, you are required to pay in full at the time you register. We have a strict NO REFUND policy and you may not transfer monies to the fall session. REMINDER: you are paying for your child's spot in camp not his/her attendance.
